The District will consider and act upon the following matters:

1. Call meeting to order and opening prayer.
2. To receive Public Comments.
3. To review and act to approve the Minutes of prior meetings.
4. To act on financial matters, including financial report, invoices/bills, investments, Investment Policy, financial institutions, required reports, audits, and revisions to budget(s).
5. To review and act on District website and community outreach matters.
6. To receive a report from the Fire Chief, Command Staff, and Administrative Staff regarding Fresno Fire & Rescue operations and activities, to review requests from Fire Department on operational expenses.
7. To review and act on matters related to construction, renovation, repair, maintenance and improvements to District facilities and real property, including engagement of design professionals or engineering services, selection of builders/contractors, acquisition of materials for same, and cooperation with other county entities regarding the development of stations, including action on construction financing.
8. To act on real estate, including sales, purchases, leases, permits, encumbrances, platting, surveying, utilities and acquisition financing.
9. To review and act on the acquisition of equipment and vehicles, including approval of acquisition financing for same and to discuss and act on the disposition of surplus or salvage property pursuant to Texas Health and Safety Code §775.0735.
10. To meet in Closed Session pursuant to Govt. Code §551.071 to consult with legal counsel on litigation, settlements or confidential matters under Texas Bar Rules.
11. To meet in Closed Session pursuant to Govt. Code §551.072 regarding real estate matters.
12. To meet in Closed Session pursuant to Govt. Code §551.074 to discuss personnel matters, including District administrative staff, fire suppression staff, Command Staff and Fire Chief.
13. To meet in Closed Session pursuant to Govt Code §551.0761 to deliberate regarding security devices or security audits.
14. To meet in Closed Session pursuant to Govt Code §551.0761 to deliberate regarding Critical Infrastructure Facility and Cyber Security.

15. To review and act on personnel matters, including District administrative staff, fire suppression staff, Command Staff and Fire Chief, including compensation, benefits, job duties, policies, scheduling, hiring and retention.
16. To review and act to engage Blich Associates, Inc., to provide advisory consulting services related to future capital improvement projects.
17. To review and act to engage Public Sector Personnel Consultants to conduct a salary and benefits study in support of the Department's Strategic Plan.
18. To review and act on an agreement with Fresno Volunteer Fire Department regarding a grant from the Department to the District, including addressing ancillary issues with the Department's corporate status.
19. To discuss future agenda items and set future meeting dates.
