

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.098479 per \$100 valuation has been proposed by the governing body of Fort Bend County Emergency Services District No.7.

PROPOSED TAX RATE	\$0.098479 per \$100
NO-NEW-REVENUE TAX RATE	\$0.096230 per \$100
VOTER-APPROVAL TAX RATE	\$0.098479 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Fort Bend County Emergency Services District No.7 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Fort Bend County Emergency Services District No.7 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Fort Bend County Emergency Services District No.7 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 17, 2025, AT 11:30 AM AT 1834 W. SYCAMORE RD, FRESNO, TEXAS 77545.

FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 7 SHALL TAKE ACTION ON THE PROPOSED TAX RATE ON SEPTEMBER 17, 2025, AT 11:30 AM, FOLLOWING THE HEARING TO BE HELD.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Fort Bend County Emergency Services District No.7 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the governing body of Fort Bend County Emergency Services District No.7 at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

the rate of growth of property taxes in the state.
